Thus, the following legislation was introduced, exhibited traction or stalled in the US Congress that may have certain ramifications on services to homeless and near homeless individuals either

positively or negatively.

HB5688	Dec. 2, 2021	Warren Davidson (R) – OH	First introduced on Oct. 22, 2021, this bill is designed to establish the People-Centered Assistance Reform Effort (People-CARE) Commission, to improve the social safety net and increase social mobility by increasing access to resources which address the underlying causes of poverty.	Recommendation: Watch One sponsor. The bill establishes a paid, eight-member commission that would create a meanstested system within numerous, current social programs. The commission would then evaluate programs for changes, consolidation, repurposing, cost reductions, outsourcing or elimination, and publish to Congress a report of those findings. The bill identifies the targets as any Federal program that is designed to specifically provide assistance or benefits exclusively to low-income Americans and includes programs targeted to low-income communities or populations. It specifies numerous programs under specific subheadings including general assistance, medical, food, housing, utilities, education, training, services, childcare and development, and community development.

HB6268	Dec. 14, 2021	Robin Kelly (D) – IL	Introduced on Dec. 14, 2021 To establish an Interagency Task Force to examine the conditions and experiences of Black women and girls in education, economic development, healthcare, labor and employment, housing, justice and civil rights, to promote community-based methods for mitigating and addressing harm and ensuring accountability, and to study societal effects on Black women and girls.	Recommendation: Watch Four sponsors Referred to the Committees on the Judiciary, and Education and Labor, Energy and Commerce, and Financial Services The task force would be established under the Department of Health and Human Services, exist for a minimum of four years, examine numerous programs in various agencies, especially those areas on education, economic development, healthcare, civil rights, and housing. Two years into its existence it will submit a findings report to Congress.

Recommendation: Favorable Twelve sponsors Requires that HUD include homeless children, youth and families in any issued rules or guidance. It also requires that the certain HMIS data be publicly available on HUDs internet website. It requires that programs housing children ensure the children are enrolled and attend school and receive other educational support and block grant funding. It requires that individuals who are most in need of assistance receive it in a timely manner. Finally the bill centers on the desire to significantly reduce homelessness and achieve prevention.
НВ6307	Dec. 16, 2021	Derek Kilmer (D) – WA	First introduced Dec. 16, 2021 To amend title 38, United States Code, to establish a pilot program to build tiny homes for homeless veterans.	Recommendation: Favorable Seven sponsors This is a four-year pilot program of five villages across the U.S. built by veterans, learning construction skills in the process under the guidance of a non-profit organi- zation. The non-profit will also provide counseling and case management services. Each home would range from 240 square feet to 340 square feet.

HB6411	Feb. 2, 2022	Mark Takano (D-CA)	Introduced on Jan. 18, 2022 To amend title 38, United States Code, to make certain improvements in the mental health care provided by the Department of Veterans Affairs	Recommendation: Watch Ten sponsors Reported out of Subcommittee on Health. The bill has several provisions. It asks for more outreach for mental health and suicide prevention, expansion of the Vet Center workforce, expansion of mental health training, expansion of scholarships and loan repayments for mental health providers, increase in the Veterans Crisis Line, research and pilot programs for improvements to the Veterans Crisis Line, expansion in outreach programs such as Solid Start, Buddy Check and Justice, and expanded research in sleep disorders, mental health, substance use, treatment, suicide and brain health. Adds \$33 million to the VA budget.

Recommendations: Favorable = the bill appears to be favorable to most agencies in the coalition; Unfavorable = the bill appears to be unfavorable to most agencies in the coalition; Watch = At this junction the bill does not appear to be either favorable or unfavorable. The Inspector General of HUD will examine all CoCs for violations during the preceding 36 months.
HB6437	Jan. 20, 2022	Jamaal Bowman (D-NY)	First introduced on Jan. 20, 2022 To amend the Low-Income Home Energy Assistance Act of 1981 to increase the availability of heating and cooling assistance	Recommendation: Watch 22 sponsors The bill notes that only 16 percent of income-eligible households received funding under the current program. It request \$40 billion per year for the next ten years. It suggests that federal agencies appropriate funding be used to prevent energy shutoffs to needing families, ensure access to heating a cooling, increase outreach, expanding eligibility and actively weatherize low and moderate income housing.
